SUBJECT: National Charter

TO: National President, KWVA

BACKGROUND

Attempts have been made for the past several years by the Korean War Veterans, Inc., to obtain a Federal Charter [Title 36, US Code]. These efforts have not been successful for a variety of reasons. The major reason for the denial can not be actually determined, however, it is believed that the outstanding objects, if addressed timely and appropriately can be overcome.

ACTIONS TO DATE

The proposed bills were redrafted and submitted for review. The Senate and House both approved the draft bill, verbatim, and filed same. The Senate Bill is S. 1512 sponsored by Senator Sarbanes and the House Bill is HR 3476, sponsored by Congressman Hoyer. Both Bills were filed simultaneously on July 27, 2005.

POSITIVE ACTIONS

There was never opposition to the passage of the bill in the Senate. It is believed there will be none this year.

NEGATIVE ACTIONS

The House Bill has never successfully moved out of the Judiciary Committee and Subcommittee on Immigration, Border Security, and Claims.

The Judiciary Committee Chairman is Congressman F. James Sensen- brenner, Jr., Republican, Fifth District of Wisconsin.

The Subcommittee on Immigration, Border Security, and Claims Chairman is Congressman John N. Hostettler, Republican, Eighth District of Indiana.

MORE NEGATIVE FACTORS

The Staff Director for the Subcommittee on Immigrations, *Border Security, and Claims*, is Cynthia Blackston. All the information which I was able to obtain indicates that this person is the real reason the Bill has never moved. The reasons for her personal and bitter opposition to this particular bill is unknown, but believed to be the result of an inability to work around a mutual

detestation of each other on the part of Blackston and former KWVA contact person(s). Further it has been reported to me that Ms. Blackston has verbally stated you *will get a Federal Charter over my dead body.*

NEGATING ACTIONS

I believe and recommend that a concerted effort must be made directly with Congressmen Sensenbrenner and Hostettler to offset Ms. Blackston's efforts. A federal employee should not hold the power to determine what is good, bad, or indifferent to over 5 to 7 million Korean War Veterans. Therefore, we need a concentrated and unified effort to overcome identified opposition, and gain the high ground.

I am proposing to prepare a list of key Members of the House identified to receive a personal letter which I will write, signed by the National President. These letters would be forwarded to some trusted individual in the vicinity of the Capitol to hand-carry for delivery to the offices of the Representatives. Director Robert Banker, Maryland Chapter might be the individual for this task.

I further request that each KWVA member write a letter to their Representatives requesting support for H.R. 3476.

ADDITIONAL ACTIONS

Request all suggestions, comments, and recommendations be forwarded to the Director Legislative Programs, immediately for consideration.

My name is Jim Lester, an aide to Congressman Renzi. Thanks for your email on HR 3476. The Judiciary Committee will not consider bills granting federal charters for the foreseeable future. Its reasoning is that there are no qualifications for receiving a federal charter and no oversight of organizations that have received federal charters in the past. Since a federal charter denotes a type of approval by Congress, without oversight by Congress, an unfit organization could use this designation to the detriment of the public.

Since there is no oversight function, Chairman Sensenbrenner has decided to deny federal charters to all organizations seeking such charters. This policy may change sometime in the future, but it is doubtful in the near term. Thanks for your email.

As President of the Korean War Veterans Association, Inc., I am concerned for the well-being of the approximately seven and one half million American Military Service members that served in the Korean War during actual hostilities and in subsequent roles to preserve the freedom and independence of the Republic of Korea and the security of the United States in the Far East.

On July 27, 2005, the 52nd Anniversary of the signing of the Korean Armistice Agreement, Representative Steny H. 





Dear Senator Vitter,

Jimmy Faircloth and I have been trying to reach your office on our behalf (S.1512). I do not believe that either one of us was successful.

It is a source of GREAT sorrow and defeat to find that the Louisiana Congressional delegation—my delegation, your delegation—has refused to exert themselves on the behalf of the 5 to 8 million veterans of the 55 year old Korean War. It is estimated that there are at least 96,000 Korea veterans in Louisiana. I was perplexed to note that you did not support our organization in your previous term, in the House, either.

We find it very difficult to understand why our organization—the only national veterans organization presently headquartered in Louisiana, a Louisiana business, our funds in Louisiana banks, our expenses and purchases bringing gain to Louisiana—is treated as lower than second rate veterans by your colleagues. This is not right.


