Released from Active Duty in 1953, I returned to finish college and earn degrees in business.

For 30 years, 1959-1989, I was an *American Red Cross* staff member, progressing from field to senior management positions in both the *Service to the Armed Forces* and the *Service to Chapters* branches. I was a Field Director in the US, Spain and Germany, and an Assistant Director in Vietnam (1967—1968) and in Japan/Korea (1969-1971). My last assignment, for an unprecedented 7 years, was as the Managing Director, O-7E, in charge of all American Red Cross operations in Europe. Since retirement in 1989, I have continued to serve as an ARC volunteer.

As a KWVA Member, I've participated fully in Shenandoah Valley Chapter #313, Winchester, VA, activities (currently 105 active members). As First Vice Commander I helped build our local Korean War Memorial, served two terms, followed by two terms as Commander, as well as a Virginia Department Director and VP. I have traveled to attend many regional and national events, which routinely include KWVA and ROK Embassy functions in Washington, DC.

As a Director on the National Board since 2016, I chair the Bylaws Committee, and have worked on the Mission & Vision, Recruitment & Membership, Graybeards, and Scholarships Committees. I've also agreed to be on the Executive Search Committee. As a result, I have learned and know well our business, its needs and goals.

In summary, I offer a professional and organizational background well tested and prepared to continue helping manage the KWVA as 2nd VP. Our Board and Chapters face critical, sensitive issues in this period of significant transition and turmoil. We must find common ground, collaborate and cooperate.
