THEY HAD PANTYHOSE OVER THEIR RIFLES!

When first I asked KWVA President Dick Adams to run an ad for the Pantyhose Brigade, he asked if I was pulling his leg. Well, thousands of legs got pulled — over guns, equipment, helicopter air filtration systems and anything else needing protection from Saudi-Iraqi-Kuwaiti sand.

But this was not about pantyhose. . . this was about American people, pulling together like never before in history, for the troops, for America and for the Red, White and Blue! I'm proud of you and I'm proud to have been a part of this effort!

Folks, you did it! Some 5,000 pair of used, clean pantyhose made their way across land and sea to our troops in the Gulf. They came in envelopes of one, and boxes of 300; short to tall, narrow to w-i-d-e, in desert colors of taupe and beige, in battle shades of black and blue, in hot tones of yellow, pink, and scarlet red.

They came with letters of encouragement and notes of support from women who recalled the stocking shortage of WWII; from folks who wanted to do something — anything — to help; from husbands who unabashedly requested mesh leftovers from their wives; and from college kids who gave their full support.

They were collected at churches, gas stations, military support posts, schools, veterans hospitals, VFW posts, and college campuses. They were announced — thanks to KWVA readers — in newsletters, college papers, local papers, national papers and a score of radio talk shows from coast to coast; AND I'm told a song called "They're Sending Panties to Saudi" was playing daily by a radio station in Florida.

Most important, they were received — and used by the guys who won the war! The Bob Hope Christmas Special featured an excellent shot of ground troops moving across the desert; sure enough! they had your pantyhose over their rifles.

AS A RESULT OF QUESTIONS ASKED LAST JULY 27 AT REUNION

Graybeards asked questions starting last July about the skyscraping Memorial costs and snail-speed progress. The editions of Sept. 1990, Jan. 1991 and Mar. 1991 summarized the effort that started when Graybeards was told the memorial costs "are none of your business"; and "the average veteran does not understand those things"; and "if you want more information, go through the Freedom of Information Act." The following two letters have been received and are published per their requests:

"Dear President Adams: I regret that I must tender my resignation as a member of the Board of Directors, effective upon your receipt of this letter.

"This action on my part saddens me as I considered it a privilege to serve my fellow Korean War veterans. However, the path the Association has chosen to follow, as carried in the March special issue of

"The Graybeards" is one that I cannot support.

It is a position absent full facts and which is devoid of justification. It is difficult for me to accept that the editor, and the author of the other article, placed their views in print without the knowledge of the leadership of the Association. Since both occupy elected and/or appointed positions in the Association, I must assume their views have the approval of the Board. Given that this policy position is one of which I was not aware and with which I do not agree, honor demands my expressed objections and my action!

"I have not been unaware of the concern which has surfaced in the Association concerning the progress of the Memorial. But, that it has progressed to the point expressed in the newsletter leaves me amazed and dismayed! Further, I have serious reservations that these views are shared by the mass of our membership. To the contrary, I believe that, when properly informed, they support the need for an orderly process of design development even though they are understandably frustrated by the

inherent obstacles that are a by-product of that process.

The simplistic view that, somehow, the erection of a major national memorial in our Nation's sacred area can be achieved without due process demonstrates an absence of knowledge of the extreme sensitivity surrounding our Memorial. It is not just a question of satisfying Korean War veterans. There are other considerations which, while not necessarily more important, are equally imperative! Law, and Executive Orders, proscribe and prescribe how the various entities involved relate to the process. Like it or not, their interests and authority must be served!

Those who opine that the KWVMAB has no function in the process of design approval fail to understand the provisions of PL 99-572. Site and design selection and recommendation to ABMC, are a function of KWVMAB. Inherent in that responsibility is final design, not just design concept! Anything less would serve to remove from the process the only element whose primary motivation is to serve, protect and represent the interests of the Korean War veterans constituency. Absent the KWVMAB, the proposed Memorial would be subject to other pressures that might, or might not, result in the kind of Memorial we all

desire.

"On a more sensitive note, I deplore the implied attack in the newsletter on the KWVMAB. This infers a criticism of the chairman. Gen. Stilwell, without whose leadership and dedicated commitment to the mission, would find the Memorial much further from realization. I. more than any, know of his total devotion to the task. He has earned, and deserved, better from the KWVA!

"Equally distressing to me is the ignoring of the nature of the difficulties the design approval process has encountered. These are well known by the KWVA and have been fully dialogued and documented. Had more information been desired, it was only a phone call or inquiry away! The failure to present the entire story is a disservice to our membership.

"An example is the presentation of cost escalation. This is a result of the evolution of the design concept and estimates of cost as the design moves to the construction phase. The KWVMAB, and the involved Commissions, orient on an appropriate and approvable design! The costs result from that - - they do not determine design! In the end, the goal is a Memorial that will stand the test of time and purpose. Anything less is unacceptable.

"I do not infer criticism of any! All who have labored to make KWVA a viable part of the family of veterans organizations have my admiration and respect. My purpose is to question the course upon which the KWVA has embarked. To my past fellow Directors, I urge your reconsideration. To KWVA members, I urge you to express your desires, based upon all the facts!"





THAT NOVEMBER 1990 PBS PROGRAM ON KOREAN WAR ANGERED MANY

Last Nov 1990 the PBS aired their version of the Korean War. Graybeards received many letters from outraged people. We selected the following two letters as not only typical of those received, but also as being straight explanations of the truth:

ACCURACY IN MEDIA, INC.

"We at Accuracy in Media share the outrage of many Korean War veterans at the recent PBS "documentary" concerning the war. With the assistance of General Dick Stilwell and other authorities, AIM did an analysis of the series, a copy of which is enclosed for your information.

"But a larger question remains: why should our tax dollars go to support such a wretched presentation of history that deliberately maligns both the American military and our ROK ally? "We urge that these members of Congress be asked to do two things: (a) direct the Government Accounting Office to do an audit of PBS to determine if it is complying with the law requiring balance and objectivity in its presentation of controversial subjects that are financed either directly or directly with Federal funds; and (b) have their committees commission a study by an objective media study group (such as the Center for Media and Public Affairs, Washington, D.C.) to evaluate the fairness and accuracy of PBS documentary programming.

LETTER TO THE EDITOR

Dear Editor, Will the war always be forgotten? In a letter we Graybeards recently received from "The American Historical Foundation" about the Commemorative .45, the letter states that "38,000 Americans will die on the Korean peninsula"!

In the June, 1990 issue of the magazine "Military", page 42, Maj. Gen. Henry Mohr said, "the cost of the Korean war was 33,629 American dead and 389 missing!

In the July, 1990 issue of the "Readers Digest", in the article titled "Veterans of a Forgotten Victory", page 74, Ralph K. Bennett said, "nearly 38,000 Americans died in Korea"!

In the November, 1988 issue of the "American Legion" magazine, page 8, Nat'l Cmdr. H.F. Gierke said to all veterans; "We cannot forget the sobering statistics of Korea: 33,600 killed in combat, 21,400 non-battle deaths and 389 still missing in action! On the same page Gierky used the word Vietnam 12 times. Further, on the same page, the American Legion Commander boasted, "2.7 million Legionnaires donated nearly \$1.3 million, making the legion the single largest contributor to the Vietnam Memorial."

Over the past 15 years, the thousands of articles about the Vietnam War, I have never read or heard of anyone separating the combat dead from the non-combat dead, here they are; Vietnam - - combat dead 47,253, non-combat dead 10,449 that incurred over 16 years.

My question to all these Korean war mis-quotes is: If 33,000 or 38,000 died on the Korean peninsula, where did the other 16,000 to 22,000 die in 37 months?

For example, statistics tell us that 1200 U.S.A.F. personnel died in combat in Korea, but there are 919 A.F. MIAs somewhere over-there, and some 5,884 A.F. "other deaths". (Vietnam total A.F. dead, 2318).

I know of many Korean War A.F. deaths, 18 of them were comrades: 5 vanished in N. Korea, two C-46 nightly scheduled couriers crashed into the Sea of Japan, shortly after takeoff (30 days apart) from K-18 airfield, breaking up on impact, killing a total of 8 crew members and 15 military passengers, some of the passengers were hitch-hikers (names not on any manifest). Only 3 bodies were ever found, I always presumed that sharks had a meal with the other 20. Sabotage was suspected, but no investigation was ever made. Five others were killed in an air crash in Japan.

In many cases, there is a very fine line between "combat deaths" and "other deaths". The graveyards do not differentiate. There is something very wrong! Footnote: The Korean peninsula (N. & S. Korea) is about the shape of Florida, but about 50 percent larger! Yes I am "picky" when it comes to the Korean war.



THIS IS TO CLARIFY WORDING OF BY-LAWS ON COST OF DUES

Various misunderstandings, grammatical errors and typographical mix-ups have created a number of instances wherein mixed signals have been sent/received on our KWVA By-Laws. So here's a plain language statement of:

ARTICLE II. SECTION 2 DUES

"A. Amount of Dues. Payment of dues is a condition of beginning or continuing membership."

NATIONAL DUES are payable to the address of the National Membership Chairman (K.W.V.A.; P.O. Box 12205; Baltimore, MD 21281).

<u>Regular Members</u> shall pay \$15.00 per year and is repayable on the member's anniversary date. A current membership card will then be issued by the Baltimore chairman, <u>each year</u>, <u>Lifetime Members</u> will get only one card issued, (\$150.00).

<u>Auxiliary and Associate Members</u> shall pay NATIONAL DUES of \$12.00 per year; renewable on anniversary date. A current membership card will then be issued by the Baltimore chairman <u>each year</u>.

Congressional Medal Of Honor recipients, ex-Prisoner-of-War, Gold Star Mothers and Wives, and Honorary Members, upon application shall not be required to pay dues. They may choose to do so at their own discretion. A current membership card will then be issued by the Baltimore chairman.

Any and all members are free to choose to be Member-At-Large and not belong to any chapter.

Germ Warfare claims. Posters — examples?

Of course, similar activities by the North Korean and Communist Chinese People's Armies and by the Soviet Union.

"This confusing little story does have a happy ending. About two years ago I thought it would be nice if I could find some of my old friends from CO A, 27th INF, 25th DIV. I started my search with help from three others who have been in touch over the years by remembering where some of the people were from.

"In most cases phone searches were usually successful, but not always, so we had to find another way. Well, Vic Gerst's name popped up on the 25th Div roster; he was in Co A; he sent me a copy of CIB orders with 140 names including service numbers.

"That was a start, but I was also aware of the fact that St. Louis records center could, if they wanted to, send you a roster of the unit strength at that time when we were assigned to the unit plus service numbers. All this is available under the Freedom of Information Act of 1974; using Standard Form 180.


"You must have a service number, or in later years have a Social Security number which is almost impossible to obtain unless you happen to have an old roster of your unit. Some of the vets have no record and in some cases the letter cannot be delivered as they have moved after all these years. A lot of people just do not respond to our letters.

"I thought if I were to have the VA Records Processing Center put the Social Security number on a stamped envelope with the individual's name on it and have them send it to the Social Security Administration in an envelope which I provided they might forward it to the person I was looking for. At that point I struck out but got my foot in the door.

"This might be of help if you are looking for your old buddies: it takes a little doing but can be done. I do have my roster from St. Louis and am still searching. I would be more than glad to help anyone. All you have to do is call or write me; RICHARD DAHMS; 1880 Bridgeview Dr.; Neenah, WISC 54956. Phone 414-722-2997."



"IN NOVEMBER OF 1986, I WROTE A LETTER"

Streator, Illinois is very proud of its Veteran Plaza. There are memorials for WWI, WWII, Korea and Viet Nam, all in the southeast corner of City Park.

In November of 1986, I wrote a letter to the "Voice of the People" column of the local newspaper, asking why there was no memorial for the men who were lost in the Korean "conflict". (A high school friend had lost his life before he turned 18 years of age.) A few days later a WWII Air Force veteran answered the letter and offered his help. His name is Howard H. Minick. Working together, we organized a small group of veterans and got the ball rolling.



With fund-raisers, canisters and generous donations, we were able to break ground in August 1987; and with the help of many, completed the memorial in June 1988.

Enclosed are pictures of the Korean Memorial, which was dedicated June 25, 1988, the 38th anniversary of the start of the "conflict" in Korea. We have three poles and fly the United States Flag, the POW/MIA Flag and the State of Illinois Flag. THE KOREAN WAR VETERANS MEMORIAL DESIGN By Blaine Friedlander

"On March 22, Fine Arts Commission representatives, a special task force of the National Capital Planning Commission (NCPC), a representative of the American Battle Monuments Commission, the architects, and members of the Korean War Veterans Memorial Advisory Board met in session and approved in principle, a modified design. The design still has a column of 38 troops marching or trudging toward an American flag, with a wall to their right depicting the contributions of the supportive elements used during the Korean War. There is a quiet reflecting pool with a memorial stone properly honoring the KIA/MIA's. The other 20 nations who joined with us under the UN banner will also be recognized in a dignified manner. No names of KIA will be included.

"During the first week of April, the NCPC will meet to hear the task force report and to vote on this design. It may not be smooth sailing, for two of the commissioners who expressed opposition to the memorial design and location were not part of the task force. Two of my informants advised that there will be meetings to reduce this opposition and obtain NCPC approval of the design and that the opposition will try for additional delays.

"The National Capital Memorial Commission (NCMC) and the Fine Arts Commission have already given ABMC a green light to continue to develop this design. Once NCPC does the same (which is expected in April) then the detailed design development phases of each statue and the wall must go through the same review cycles with Fine Arts and NCPC. Final approval will include completed design drawings which can be used to get bids and let the contracts. There will be several meetings as the design is further refined.

"The National Capital Planning Commission will meet between the time this is written and you receive this Greybeards. Their function differs from the Fine Arts Commission, in that they represent the several governmental bodies dealing with the administration of developmental law. Their task is to see that commemorative work will stand up to the test of time and elements and is in line with the existing governmental policy. This board may take as many as three more sessions. "The sponsoring organization for the Memorial has always been The Battle Monuments Commission. They let the contracts and see that the engineering is done. There is sufficient funding for the memorial. All that is necessary is to shepherd the design through the above cited bureaucratic maze.

"When this process is finished, the ABMC will submit the completed detailed design, drawings, and contracts to the Secretary of the Interior and, if approved at that time will receive a construction permit.

"Gen. Adams, Secretary of ABMC, Col. Bill Ryan, and I were discussing the need to extend the time for two years, and the unhappiness of the KWVA for the need for such an extension. General Adams explained that there was a chance that the contracts could be completed and the construction permits could be issued this October, but the ABMC did not want to be caught short, and sought the extension of time to protect the memorial. This appears to be prudent, and even if the reader does not like the extension, there in, in my opinion, little that we can do about it.

Senators Glenn and Rudman, with Congressman Montgomery and Solomon, will introduce the extension legislation upon the return of Congress to session on or after April 8. The KWVA position is that we desire the memorial built and the dedication be on July 27, 1993.

THE KWVA FEDERAL CHARTER

"Yesterday, I met with the one United States Representative who can obtain federal recognition of the Korean War Veterans Association. I understood that within a very short time we, the KWVA, will be a nationally recognized veteran's organization. In the past, this gentlemen had considered federal recognition as an "ego trip." When his staff understood from the KWVA the urgent need, the appointment was made, and this important item on our legislative agent was fully discussed. If all goes well, we shall be federally recognized in short order."

FACT SHEET

THE PRIMARY PURPOSE OF THE ASSOCIATION

- 1. To seek out the truth about our 8179 M.I.A.'s and 389 P.O.W.'s that didn't return.
- 2. Raise the awareness of the American people about the Korean war and those who served in it.
- 3. Raise and contribute funds for establishment of the National Memorial in Washington, D.C.

The Korean War Veterans Association was founded in July 1985. The place was near Arlington National Cemetery - - where we held the first of our annual ceremonies to commemorate those who had died, who are missing, and who were prisoners of war. Thirty-nine Charter Members enrolled in our Association at the first meeting. We returned to Arlington in 1986 for our ceremony and convention, and celebrated the growth of the organization which had taken place in that first year.

In 1986, we convened again in Arlington, Virginia, and in 1987, in cooperation with "No Greater Love," we dedicated a Meditation Bench at the Cemetery to memorialize those who died in the war. At our convention that year we also identified, as an objective for our Association, helping to raise money for the Korean War Veterans National Memorial in the nation's Capital.

By the summer of 1988 we had grown to over 2,000 in number, and our Arlington Cemetery ceremony was highlighted with the presentation of our first check, for \$10,000, to the Memorial Fund. Following the ceremony, we again visited the Meditation Bench and attended a reception at the Korean Embassy. In September, 1988, several of our members participated in the ceremony to announce the approval of the site for the Memorial.

On November 11, 1988, Abigail van Buren ("Dear Abby") published a letter from one of our members asking Abby's help in obtaining Memorial donations from her readers. Abby responded by making her own donation and asking her readers to do the same. More than 35,000 readers of "Dear Abby" contributed over \$340,000 to the Memorial Fund.

In the Spring of 1989, we sponsored a ceremony at the Memorial site and made another \$10,000 donation to the Memorial Fund. On Flag Day, June 14, after conferring an Honorary Membership on Dear Abby in Washington, D.C. more than fifty of our members watched

President Bush unveil the winning design for the Memorial at a ceremony in the Rose Garden at the White House.

By convention time in July, 1989, our membership had grown to more than 5,000. General Stilwell, Chairman of the Korean War Veterans Memorial Advisory Board, spoke at our ceremony in Arlington National Cemetery, and we donated an additional \$50,000 to the Memorial Fund. Colonel Dave Hackworth, author and a veteran of both Korea and Viet Nam, spoke at our dinner. Bob Hope was our honored guest and spoke at our convention banquet.

Late in the fall Dear Abby again provided the basis for another successful fund raising campaign. This time she sponsored the sale of a book written by a physician from California who had been a soldier in the ROK Army during the War. Sales of the book earned over \$200,000 for the Memorial Fund.

By the end of 1989,our Association had contributed \$80,500 directly to the Memorial Fund. In addition, through the efforts of Dear Abby, we were also recognized as responsible for an additional \$340,000 contribution to the Memorial Fund. Therefore, by May 1, 1990, at a fund raising gala for the Memorial Fund, our organization was recognized as the third largest contributor to the Fund overall.

In May, 1990 we were recognized as being instrumental in the first return of remains of American dead by the North Korean government since 1954. Our Association president accompanied the team of U.S. Legislators and other prominent Americans to accept the remains at Panmunjom, Korea, May 28, 1990.

On July 27, 1990, we held our Annual Memorial Ceremony at Arlington National Cemetery and again we were able to present another \$50,000 check to the Memorial Fund.

Our Association is living up to its promise. It has grown from the original thirty-nine Charter Members to over 8,000, and the growth continues at a steady pace. In the past five years this Association has established a track record that anyone can be proud of, and any qualified veteran of the Korean War, and all who have served in Korea since the end of the active hostilities, can be a part of it by becoming an annual member for only \$15.00, or signing up for the long haul as a life member.
